2. The first trustees of the trust shall be as stated above.
3. Mr Gurdal Singh shall be designated as the Managing Trustee, who will be incharge of day to day affairs of the trust.
4. The Managing Trustee is empowered to co-opt 10(Ten) trustees for the trust and will fixed the tenure of their appointment.
5. Managing Trustee shall have power to administer the funds of the trust and any power exercisable by the Board of Trustees, as may be delegated to the Managing Trustee by the trustees.
6. The Managing Trustee will hold office for life, until resigns therefrom.
7. The Managing Trustee shall have power to fix the term of the Other trustees of the trust and their shall not be less than Five (05) and not more than Ten(10) founder trustees.

8. The Managing Trustee, during his lifetime, shall name his successor as the Managing Trustee, and on his failure to do so, may be appointed by the Board of trustees, on such terms and conditions, as the managing trustee, or as the case may be, the board of trustees' deem fit.
9. The founder Managing Trustee and other founder Trustees shall held office Trust for his/her life time and after his/her death, only his/her legal heir shall hold the status of Managing or Lifelong trustees of the trust as the case may be and other trustees shall ordinary hold office for their fixed term, but they will be eligible for re-appointment after their expiry of the term provided that any such trustee shall also to be a trustee, when hi is requested in writing by all other trustees, without assigning any reason thereof, it vacate his office.
10. The managing trustee shall have overall power of superintendence over the affairs of the trust and shall have in particular, the power to operate the bank accounts, borrow money for the trust and carry out the objects of the trust.
11. Proper accounts for the trust shall be kept at the office of the trust.
12. The initial contribution of Rs. 11000/- made by the author of the trust hereby vests in the trustees and shall constitute the initial trust fund.
13. The Trust fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.
14. The trust shall not be applied for any purpose other than the objects of the trust as stated in Para 14 below for the Welfare and benefits of the community belongs to Sikh community or more of the following purposes.

For Welfare of Sikh community to establish, develop, run and maintenance, grant in aid to orphanages, boarding and lodging houses, Institutions for providing education, specially for the persons belonging to Sikh community and food, clothing relief, medical facility for physically handicapped and disabled persons, widows, and orphans and such other relief for the help of the poor, needy and destitute people of Sikh community.
- d. To establish, run, and maintain or grant aid, in cash or kind, for the establishment and maintenance of hospitals, medical, dental, nursing colleges, x-ray plant, CT scan, dispensaries, Maternity homes, kids Care Centres and or such other similar charitable Institution of Sikh minority spirit in India for the help and benefit and use of Sikh community.
- e. To provide scholarships, loans and financial help to poor and needy students belonging Sikh community.
- f. To establish and maintain or acquire library or libraries, for the benefit of poor and needy Sikh students.
- g. To award scholarships for the study, Research and apprenticeships to the students in India or any of the aforesaid educational purposes belonging Sikh community.
- h. To construct, established, Run, maintain and/or grant financial aid or assistance by the way of contribution subscription or donation to construct Gurudwara, Mortuary and graveyards with the presence of Sikh public.

- j. To making available to poor and needy persons of Sikh community the benefit of a sanatorium or health home or homes for rest and Recreation at any place in India or otherwise making available to poor persons for the benefit of a change of air which they are unable to secure by their private means with the preference to Sikh community.
- k. To grant relief by the way of giving donations, subscriptions, monetary or financial assistance or aid to the dumb, blind, deaf, orphans and widows and poor persons or needy persons are to any organisations are institutions.
- l. For the advancement of propagation of education and learning the establishment, maintenance and support of colleges, schools of minorities Sikh educational institutions, professorship, scholarships and prizes are any other type of professional and non professional institutions.
- m. That the interest or other income which will acquire to the trust out of Trust money or properties after differing all costs and expenses or incidental to the administration of the trust fund, shall be applied for the Welfare and interest and benefits of general Sikh public in India.
- n. To import, purchase, manufacture or assist in manufacturing of any Allopathic medicines, Yunani, Homoeopathic or otherwise, kids, equipments, Apparatus and accessories for use of treatment of general public and for its any research relating thereto will priority to Sikh Community.

- o. To co-operate with Institutions and associations having similar aims and objects and engage in any lawful activity that may be conducive to the promotion of any or all the other objects of the trust mentioned above on no profit motive.
- p. To provide basic needful education and try to arrange basic, secondary, Higher Education and teachers training schools of the same spirit.
- q. AND FOR GENERALLY FOR THE FULFILMENT OF ABOVE OBJECTIVE.
15. To Acquire Government and semi-government land and buildings or to take long term lease, purchase or rent any movable or immovable properties from any party or to take help or give help to any charitable Institution of the same objective.
16. The said trustees shall also be entitled to take over the management of any trust or charitable institution belonging to the same aims and objects, as well as carrying out the trust under any deed of trust or charitable purpose or under any will or testamentary writings. On such terms and conditions, if any, as maybe thought Fit by term in carrying out Public Charitable purpose the benefit ware of is not restricted to a class or Sikh community.
17. The trustees hereby appointed or any of them or any future trustee or trustees will lose his/her membership in case of :-
 - a. Accepting of his/her resignation.
 - b. Losing India's nationality.
 - c. Becoming insance in solvent.
 - d. Death.
 - e. Found guilty of any misuse or embezzlement of Trust's misuse of money.

21. 34. That any other condition which is not specifically provided the provisions of Indian trust act shall apply.
35. Notwithstanding anything provided herein above, the trustees shall not do any business or make any investment, or to do any act or thing by which the trust be not recognised as a "Public Charitable Trust" entitled to Income tax relief exemption under the income tax act, for the time being in force and the rules made there under and or any of income tax scheme in this regard. It is expressly declared that the trust is irrevocable and a Public Charitable Trust and all the provisions of this deed shall be constructed accordingly.

36. Duties and powers of office bearers :-

- President:** - He/She will preside over all the meetings and give directions to the trustees and when the need arises, he/she will represent the trust in all matters concerned with the municipal corporation, and all government or semi government or other Institutions. 37. **Meetings:-** The meetings of General Body of the trustees will be called at least once in a year, while the executive body once in 3 months. Meeting of any of this body can be called earlier at short notice by the president. If an emergency arises to do so, president will preside the meeting and his absence secretary shall preside over the meeting. All meetings shall be conducted at such place and time, as may be convenient to the president, for which timely notice will be issued by the secretary of the trust to all concerned. A postponed meeting can be recalled at short notice. Secretary will record proceedings of all meetings and get signed off President and all members present in the meetings.

For this purpose the amendment required specifically is directed in agenda of the meeting. 40. Fulfilment of Conditions for obtaining No objection Certificate for from state Government by trust for establishment and maintenance of school operated by trust for affiliation with CBSE/ICSE Board, New Delhi.
- A person nominated by Director of Education (Secondary) U.P., will be the member of Committee of Management of schools.
 - 10% seats will be reserved for admission for the brilliant students belonging to scheduled caste and scheduled tribes and fee will not be charged above than the prescribed for by U.P. Secondary/Basic Education Board's schools.
 - Employees of schools shall be paid salary and admirable allowances as per employee of aided schools of state.
 - Schools shall never apply for grant from state Government.
 - Service rules for employees of schools will be prepared and maintained by committee of management of the trust.


3.OBJECTS

13. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:



(b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:

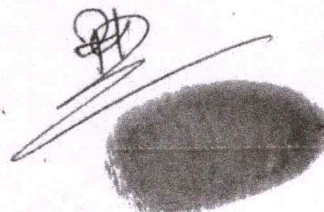

- (b) To consider such proposals submitted by Sub-committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
- (vii) To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.
- (viii) To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
- (ix) To sell, transfer or otherwise dispose of any immovable property of the trust provided the trustees by majority resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
- (x) To appoint a Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.
- (xi) To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.

- (xiv) Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely
- (a) All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
 - (b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
 - (c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.



- (d) The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
- (e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
- (f) Cost and expenses of keeping the trust property in good condition.
- (g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
- (h) The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.
- (i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto.

After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.


14. BOOK ACCOUNT:


